



CAMP MAYO WAIVER

1. I understand that there are natural streams, ponds, holes in the ground, both obscured and unobscured, hills, trees, rocks, insects, animals, and other potential hazards common to any natural forested area.
2. I agree to assume the risk of any personal injury or property damage that may occur while participating in activities at Camp Mayo.
3. I further acknowledge that this running camp can be a test of a person’s physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by lack of hydration, sleep deprivation, terrain, facilities, temperature, weather, the physical condition of participants, equipment, vehicular traffic, and the actions of other people, including, but not limited to, participants, chaperones, spectators, instructors, event officials, event monitors, and/or producers of the event. These risks are present for all participants of Camp Mayo.
4. I hereby assume all the risks of participating at this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released; from the use, by myself or others, of dangerous or defective equipment, or the use of equipment in a manner for which it is not specifically designed; and from equipment or property owned, maintained, or controlled by persons other than myself, even those whose possible liability might arise without fault or negligence on anyone’s part.
5. I acknowledge that this Accident Waiver and Release of Liability form will be used by Delta Limitless Running Club and that it will govern my actions and responsibilities at said events.

For considering my application (and/or my child(ren)’s application) and permitting me (and/or my child(ren)) to participate in this event, I agree to take action for myself, and on behalf of my executors, administrators, heirs, next of kin, successors, and assigns as follows:

I hereby waive, release, and discharge from any and all liability for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me or to my children, including during my travel to and from this event, THE FOLLOWING ENTITIES OR PERSONS: Delta Limitless Running Club; their directors, volunteers, and representatives.

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during this event. I acknowledge that Camp Mayo does not provide medical care and that I must bring any medications I need, including epinephrine injectors. In the event that I require medical care or treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I understand that I should have my own health insurance.

This Accident Waiver and Release of Liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. I hereby certify that I have read this document and understand its content.

The undersigned parent or legal guardian does hereby represent that he/she is, in fact, acting in such capacity and agrees to save and hold harmless and indemnify each party and all parties referred to above from all liability, loss, cost, claim, or damage whatsoever that may be imposed on said parties because of any defect in or lack of such capacity to so act and release said parties on behalf of the minor and the parents or legal guardian.

Transportation Waiver

As the parent or guardian of the minor registering for Camp Mayo, I consent to his/her participation in carpool and I understand and agree as follows:

1. I understand that in the course of the camp or other activity at Camp Mayo, my child will be transported by a camp chaperone. In consideration of my child receiving transportation services to/during/from Camp Mayo at Zephyr Point Conference Center, I, on behalf of myself, my family, heirs, estate, representatives and assignee's, agree to release and discharge Delta Limitless Running Club, and its chaperones from any and all present and future liability, demands, actions or causes of actions ("Claims") resulting from the "Transport".
2. In cases of a medical emergency, Delta Limitless Running Club and its chaperones may need to contact paramedics, and to transport individuals by ambulance as they deem appropriate. In instances where the issue does not appear to be a medical emergency, Camp Mayo staff are available to provide transportation. In the case of participants in summer camps and activities, this service is conditioned upon receipt of this signed Release of Claims and Indemnification Agreement (the "Agreement") from a parent or guardian.
3. In addition to the foregoing, I agree to defend, hold harmless and indemnify the Released Parties from any and all Claims released herein which may arise from the "Transport", including but not limited to reasonable attorneys fees incurred by Released Parties as a result of Claims released herein.
4. I realize that Delta Limitless Running Club and Camp Mayo chaperones reserve the right to determine when paramedics should be contacted in lieu of a Transport.

The undersigned parent or legal guardian does hereby represent that he/she is, in fact, acting in such capacity and agrees to allow his/her child to be carpooled to/during/from camp to partake in all camp activities...even in the case of a medical emergency. Signees also agree to save and hold harmless Delta Limitless Running Club and its camp staff (see below) from all liability, loss, cost, claim, or damage whatsoever that may be imposed on said parties because of any defect in or lack of such capacity to so act and release said parties on behalf of the minor and the parents or legal guardian.

CAMP MAYO WAIVER

As an applicant to Limitless Summer Camp, I, _____ agree to the following concerning participation at the camp or at any other location visited as part of the camp.

- I agree to not use or bring or have in my possession alcohol or drugs other than those approved or specified by the camp director.
- I also agree to leave at home any items which are weapons or weapon-like.
- I agree to avoid coupling and any other sexual activities. This includes boys never entering any girls rooms and vice-versa.

A violation of the above will result in immediate expulsion from camp with loss of tuition at the parent's effort and/or expense.

- I agree to respect the authority of the camp staff, following their directions and accepting their decisions. This includes instructions for "11pm lights out," as well as to cease any other activities for whatever reasons that they might have.
- I agree to attend all camp activities (including cooking and cleaning responsibilities) as designated by staff to arrive on time, and to respectfully remain there until dismissed.
- I agree to respect the needs and feelings of others, to show kindness to all that I come into contact with, and to help out whenever I can.
- I agree to refrain from any and all unchaste language, gesturing, and behaviors. This includes using profanity, public displays of affection, engaging in or seeking to engage in sexual behavior, dressing or behaving immodestly, or in general, willfully giving into or leading others into temptation.
- I agree to refrain from any and all violence, including physically or verbally abusing my fellow campers, bullying, fighting, yelling, and in general losing my temper. This includes even play fighting (NO FIGHT CLUB!)
- I agree to respond to all harsh words, threats, taunts, insults, and attacks without returning like for like, "eye for an eye," but to seek a peaceful resolution to the problem, including but not limited to seeking the help of camp staff and/or simply walking away from the situation.
- I agree to respect all property including housing, athletics, outdoor and indoor facilities that belong to the camp grounds and Delta Limitless Running Club as well as the personal property belonging to my fellow camp mates.
- I agree to respect the views, opinions, beliefs, religious or otherwise, of my fellow campers, even if I do not agree with them.

A violation of the above will be dealt with according to the severity and may include, but not be limited to, being prohibited from participating in some or all activities. A call to a camper's parents, expulsion from camp with loss of tuition, reimbursement for damages and/or being prohibited from returning to Limitless programs in the future may result.
